Licence	A licence or authorisation based on the Telecommunication Regulation issued by Telestyrelsen, granting the Service Taker the right to supply Network and telecommunication services to End Customers in Greenland via purchase of Services pursuant to this Agreement for the provision of the End-Customer services
Mobile Access	An access service using cellular technology
Mobile First	Used to designate Services or geographic areas where the preferred access technology is Cellular networks.
Network	A collection of elements such as but not limited to terminal nodes, transmission links, any intermediate nodes, which are connected so as to enable tele communications between the elements and access to same.
Network Alteration and Modifications	Any changes made to a Network, whether physical or through configuration.
New Service	A WDS that is not currently specified in Annex C to this Agreement and which Service Taker desires to purchase from TELE-POST.
Notice	Any communication to be forwarded from one Party to the other under this Agreement in writing setting out in reasonable detail the reasoning or contents of the matter and forwarded according to clause 31 of the Agreement.
